**BEGINNER CLASS:** Introduction to the sport of Agility. Previous experience not required. Dogs will be trained on basic obstacle performance. Obstacles to be performed on lead.

*Call or visit website for start dates. Class will meet on Thursdays at 7:00 PM. Six-week course for \$110.*

**INTERMEDIATE CLASS:** Dogs and handlers learn to sequence obstacles. Dog should be able to sit, stay and down on command. Focus is on obstacle performance and proficiency.

*Call or visit website for start dates. Class will meet on Thursdays at 8:30 PM. Eight-week course for \$140.*

**NOVICE CLASS:** Dogs and handlers continue to build skills for sequences and courses. Focus is on handling proficiency, sequence challenges, and Novice level course work.

*Ongoing Class. Classes meet on Tuesdays at 7:00 PM, Wednesdays at 8:30 PM and Sundays at 8:00 PM. \$50 per month.*

**COMPETITION CLASS:** Class is structured to work competition level dogs up to and at the Masters/Excellent/Elite level. Closer attention to handling skills, efficiency, and complex sequencing. This ongoing class will focus on course work and advanced skills.

*Ongoing Class. Classes meet on Mondays, Tuesdays, and Wednesdays at 7:00 and 8:30 PM. \$50 per month.*
